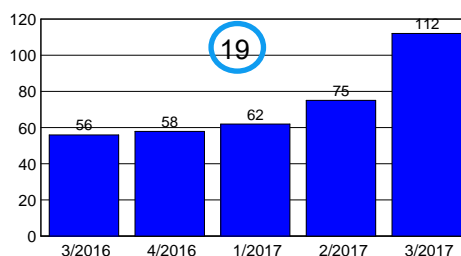

1

Mailing address where the bill is sent. This address can differ from the address of the installation when requested by the consumer.

2

Address where Meter is installed.

3

Indicates the zone where the premise is located for invoicing and water network management purposes

4

Invoice issue date for VAT declaration purposes.

5

Invoice reference number, which is used for payment via the internet (JCC Smart, direct banking)

6

You are invoiced every 3 months. The meter reading is taken on average every 92 days (+/- 5 days depending on weekends and public holidays).

7

Denotes the tariff the consumer is charged with. There are various types of tariffs depending on the type of use and the consumption. Please refer to the Charges and Fees section of our website for information on which tariff is the most suitable for you.

8

Unique installation number for each property. This can be used as a reference number for customer service purposes.

9

Breakdown of consumption charge according to the billing scales. The charge increases every 15 cubic meters. The range of billing scales is reduced for shorter connection periods than a quarter

10

Analysis of charges, which include

- The Fixed Charge which is imposed each quarter to cover part of the administrative and operational costs of the Board according to the pricing policy which the Government applies.
- The Maintenance fee which is imposed every quarter to cover maintenance costs of the water distribution network until the consumer's meter.
- The Sewerage Fee which is imposed by the Larnaca Sewerage Board (LSB) on the basis of the water consumption at your premise and the unit charge set by the LSB from time to time.
- The Additional Fee which is imposed when the previous invoice was paid after the last payment date.

11

Arrears or Prepayments against previous bills. This amount does not include arrears which, under an installment agreement, have not become due.

12

Total amount payable. When "*" appears in the total debt, it means that installments not yet due are not included. In this case, the amount of overdue installments is shown in box 20.

13

Denotes the last payment date. However, bills can be settled online for a period up to 75 days after that date. Even though this does not remove the Board's obligation to disconnect the water supply when a bill is not paid by the last payment date indicated on the invoice, nor to impose an additional fee of 10% on the outstanding amount, which will be included at the next water bill.

14

If you have arranged for your bill to be automatically settled by standing order, this field indicates the bank you operate with and the bank transfer number used for the automatic payment of your account. You can setup a standing order for the automatic settlement of your account for your convenience. This can be arranged for you at our offices with the assistance of our Customer Service Department, by presenting details of your bank account and your ID.

15

Consumption recorded by water meters installed at your premises during the consumption period.

16

The check meter difference is the difference between the consumption registered by the check meter of the building and the total consumption registered by the meters of each unit. This variance is allocated to the consumers proportionally based on their consumption. This variance is due to meter inaccuracies, use of water for watering plants, filling swimming pools etc.

17

This is an estimate when it is not possible to record the meter or if the meter has stopped registering consumption. The estimate is usually based on the previous year's consumption for the same period.

18

The Environmental and Resource Costs are integrated into your total charge and for information purposes, reference is made to this amount paid by the Water Board to the Water Development Department under the relevant legislation.

19

Graph showing the consumption of the current period and the last 4 periods for comparison purposes. Reference is also made to the percentage change of your consumption habits. Please review this diagram carefully as it may help you realize if there is a leakage from your installations.

20

Pending Instalments that are not yet due. See also the point (box with reference number) 12.
